In exercise of the powers conferred under sub-section (1) of Section 5 of the Orissa Industries (Facilitation) Act, 2004, Government have been pleased to constitute a District Single Window Clearance Authority (DSWCA) for each district in the State of Orissa to be called the District Single Window Clearance Authority for the purpose of speedy issue of licence / clearances / certification required under various enactments for setting up of Industrial undertakings in the State.

1. The said Authority may exercise the powers and perform the functions as specified in the Orissa Industries (Facilitation) Act, 2004 and the Rules made there under.
2. Government in exercise of power under sub-section (2) of Section 5 of the said Act have been pleased to decide that the District Level Single Window Clearance Authority shall consider the projects where the amount of investment is less than Rs.50 crores.
