3. The quotation shall be opened after the last date before the Purchase Committee to be held. The vendor or his representative may remain present during opening for which they may indicate their email address for communication.
4. The quantity of refilling of Cartridge shall be based on requirement and availability of funds.
5. The Vendor should furnish the GST Registration Certificate.
6. The rate quoted should be exclusive of GST. The GST components should be indicated separately with rate of GST. The make / model / Brand of items wherever necessary may be indicated. The vendor shall provide free spare and service to cartridges refilled by him which are found not functioning after refilling by the office.
7. Payment shall be made subject to supply & receipt of materials found in good condition, stock entry & drawl of funds from Treasury and shall be paid through on-line mode only.
8. The validity of rate of items should be at least for a period of one year i.e. till 31.03.2021
