**Sub: COVID - 19 Relief for MSMEs of Odisha: Revocation of Blacklisting/Debarment Orders for failing in timely execution of contracts/tenders for supply of goods and services during COVID-19 pandemic period**


1. Many MSMEs of Odisha have been Blacklisted/Debarred by State Government Authorities from participation in future tenders for supply of goods and/or services due to failure of those MSMEs in timely execution of procurement contracts/tenders during COVID-19 pandemic period.
2. After careful consideration of the difficulties faced by these MSMEs in executing their contracts during the COVID-19 pandemic period, State Government have now been pleased to revoke all such blacklisting/debarment orders, with effect from the date of issue of this notification, where original delivery period/contract completion period as stipulated in the contract was between 19.02.2020 and 31.03.2022 (both days inclusive). All such blacklisting/debarment orders are hereby deemed to be revoked by this notification.
3. This relief shall be extended to all affected MSMEs of Odisha by all State Government Departments and their subordinate offices/authorities, called in whatever name, including societies, cooperative societies, autonomous bodies, State PSUs/Corporations, educational institutions, etc. functioning under administrative control of State Government Departments.
4. This notification supersedes all such blacklisting/debarment orders issued by State Government authorities of various types as mentioned in previous paragraph. **Since all such blacklisting/debarment orders are deemed to be revoked by this notification, these authorities are not required to issue individual order to revoke the said blacklisting/debarment orders.** By virtue of this notification, the said MSMEs shall automatically become eligible to participate in all tenders for supply of goods and/or services published on or after the date of issue of this notification. This notification shall be cited to consider them eligible in all future tenders.
5. Relief given to the said MSMEs by this notification shall not be applicable to them in respect of any tenders published till the date of issue of this notification.
6. This is issued with prior approval of Finance Department obtained in OSWAS File Number FIN-ES2-MISC-0084-2023.
