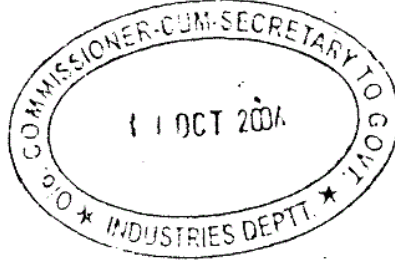

I am happy to inform that the Micro, Small and Medium Enterprises Development Act, 2006 has become operational with effect from 2 October 2006.

2. A copy each of the following notifications are enclosed for your ready reference:

- (i) Principal Notification No. S.O. 1154(E) dated 18 July, 2006 that MSMED Act, 2006 becomes operational from 2<sup>nd</sup> October, 2006 (Annexure-1)
- (ii) Notification No. S.O. 1622(E) dated 27 September, 2006 for the constitution of the Advisory Committee (Annexure-2).
- (iii) Notification No. S.O.1642(E) dated 29 September 2006 for classifying the Classes of Enterprises. (Annexure-3).
- (iv) Notification No. S.O.1636(E) dated 29 September 2006 for the Authority for filing of Entrepreneurs Memorandum (Annexure-4).
- (v) Notification No. S.O. No.1643 (E) dated 30/9/2006 for filing of Entrepreneurs' Memorandum (Annexure-5).
- (vi) Notification G.S.R.596 (E) dated 26 September, 2006 for Rules for National Board for Micro, Small and Medium Enterprises(NBMSME) (Annexure-6).
- (vii) Model Rules of Micro & Small Enterprises Facilitation Council (MSEFC) under the MSMED Act, 2006 as approved by Union Minister (SSI & ARI) for consideration by States/Union Territories as per the power conferred by section 30 read with sub-section(3) of section 21 as per the Act (Annexure- 7) on the States.

3. In this regard please refer to my D.O of even number dated 20 September 2006 and O.M. No.1(3)/2006-MSME Pol. dated 27.9.2006 wherein, to make the MSMED Act, 2006 fully operational by 2 October 2006, we had requested you for taking certain steps. I am reiterating the same for your convenience, hereunder:

- (i) With a view to assisting the State Governments and bringing uniformity in the constitution and functioning of Micro and Small Enterprises Facilitation Councils (MSEFCs) in all the States/Union Territories of the country, we had forwarded model rules of MSEFCs for your consideration and adoption by your States/UTs.

After taking into account the above rules, one or more MSEFCs were also to be constituted by the States/UTs for adjudicating upon references relating to delayed payment by MSEs.

- (ii) In pursuance of sub-section (4) of section 8 of the MSMED Act, the authority for filing of Entrepreneurial Memoranda (EM) by micro and small enterprises has to be notified by the States/UTs.

I shall be grateful if you could kindly send a copy of the same if already carried out. Otherwise, a date may please be indicated by which it is likely to be constituted. I may like to add that constituting MSEFC by each State is mandatory as per the provisions of the MSMED Act, 2006.


4. I have already requested you to disseminate information on the provisions of MSMED Act, 2006 among Micro, Small and Medium Enterprises of your State/UT and to enlighten the officers of District Industries Centre and related institutions. You may also consider to bring out advertisements for its publicity to facilitate information in this regard. I hope that you have initiated such programmes and made wide publicity of the same to sensitise the officers and entrepreneurs of your State/UT.

5. I shall be thankful if I am informed about the status of the action taken before 15.10.2006 along with copies of the notifications, if issued, along with soft copy at ~~nbmsme@sidonrail.net so as to enable me to place the same during the meeting of the~~ Principal Secretaries/Secretaries of all States/UTs, scheduled to be held on 18.10.2006.

6. We have already forwarded the notice for this meeting of all the Principal Secretaries/Secretaries of the States/UTs on 18.10.2006. I take this opportunity to once again request you to attend this meeting.
